

# **Privacy Policy for mobile application**

## **1. General information**

## **2. Terms of Use**

When downloading, installing mobile applications "Halkbank MobileBank", you are in full you accept the terms of this Policy and express your certain consent to the processing of your data in a manner and for purposes as described in this Policy. If you do not agree with this Policy, please, Do not download mobile applications.

The organization may from time to time modify and / or supplement this Policy without prior written notice to users. You need with a periodicity of one month to get acquainted with this Policy for amendments and / or additions made to it. If you continue to use application, you confirm your agreement with the new edition of the Policy.

## **3. Objectives of collecting and / or processing user data**

The organization collects and processes your data, pursuing the following objectives processing your personal data, namely: the functioning of the application, and also more convenient, fast and safe use it for you.

Data that can be collected and processed by the organization and its partners in communication with the use of your mobile application "Halkbank Mobilebank":

- Your mobile phone number and mobile network data;
- your bank card number;
- Your e-mail address;
- gps-data about the location of your mobile device;
- information and information transmitted by you through the feedback form and other communication channels (email, phones, etc.), including the attached files (in number of images)

#### **4. Use dissemination and transmission of your data**

The organization can collect, record, organize, store, modify, combine, group, depersonalize, delete, modify and use your data with other information to support, manage and develop the application.

You hereby express your voluntary consent that your data may be provided to third parties in the following cases:

- when it is necessary to comply with the law;
- in cases where it is necessary to protect human rights and fundamental freedoms.

#### **5. Storage of data**

This consent can be terminated at the request of one of the parties from the moment receipt of the second party's application for termination.

#### **6. Other duties of the parties**

You are responsible for the completeness and reliability of the data you provide. In case of inconsistencies and / or incorrectness in the data provided by you, they must be changed, including by contacting the organization's specialists, as indicated in the "Contacts" section.

The organization reserves the right to delete and / or modify your data.
